NOTE: Only candidates who attend CBT will get a refund of their examination fee as mentioned above.

11.0 Candidates are required to go through the Post Parameter Table and Vacancy Table of detailed CEN No. RPF 01/2024 and CEN No. RPF 02/2024 to ascertain their eligibility before applying through ONLINE mode. Only one ONLINE application should be submitted by a candidate against each CEN separately i.e., **Only one application against CEN No. RPF 01/2024 and only one application against CEN No. RPF 02/2024.** Applications should be submitted only through any of the official RRB websites listed in Para 13 below. Any attempt to submit more than one application by a candidate against a CEN shall result in disqualification and debarment.12.0 **Eligibility:** Eligibility of the candidates will be provisional based on the details furnished by the candidates in the application. Candidates must satisfy themselves that they are eligible for the post.
